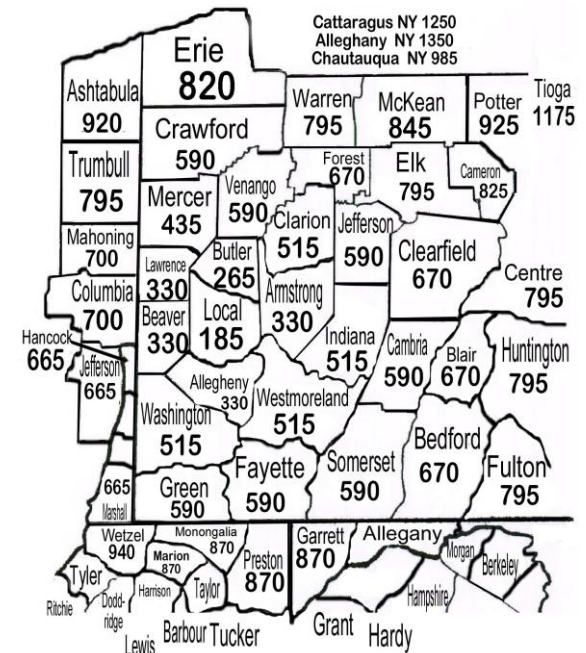


- How to Order:**
1. Determine the height from footer to grade.
  2. Refer to the Basement Entrance chart and select the size to assure the top of the unit will be 2" - 6" above finished grade.

**Job Requirements:**

1. Width of opening in foundation wall maximum 41" for all types.
2. When foundation is backfilled leave minimum work area for Basement Entrance installation as shown.
3. After Basement Entrance installation fill with gravel.
